

Often, the holidays come with lots of time off to read a good book. December is "National Read a Book" Month. This a good time to encourage our young people to pick up



In St. Lucie County, Sean Boyle and his staff at Children's Services Council understand the importance of reading especially for disadvantaged children and communities. Its investment in the St. Lucie Reads initiative, led by John Cesar is a game changer for children, and aids in closing the literacy gap in our community. I learned through this campaign that middle-income families have 13 books per child while low-income families only have ONE book for every 300 children. This initiative is a campaign that focuses on ensuring that all students in St. Lucie County are reading on grade level by 3rd grade by emphasizing the importance of reading and placing little libraries throughout the community. Did you know there is a correlation between reading below level at 3rd grade and poor outcomes for youth including incarceration? According to the Children's Defense Fund summary report, we have an opportunity to interrupt the "Cradle to Prison" pipeline through education. Education begins with reading and is a key factor in increasing opportunities for success for all children in St. Lucie County. With the multifaceted impact of COVID on the economy and projected learning loss for so many youth, it is more important than ever to get books into the hands of our

children, especially in disadvantaged communities. Let's continue to support St. Lucie Reads and wrap a book or two as a present to donate to a young person. Why-- because Reading is Fundamental! Happy Holidays to you and yours.

Most Local Alcohol Retailers Pass Compliance Checks

The St. Lucie County Sherriff's office continues to work in partnership with Drug Free St. Lucie on substance misuse prevention of underage drinking, by utilizing the evidence-based strategy of "compliance checks". The purpose of compliance checks is to discourage the sale of alcohol to minors.

On November 21^{st,} 2022, the St. Lucie County Sherriff's office conducted alcohol compliance checks at 18 pharmacies and all 18 were in compliance. Walgreens store# 4391, located at 2501 Virginia Avenue in Fort Pierce, was one of the pharmacies that was involved and Manager Jeff Lipston, who has been with Walgreens for 24 years, stated that it is Walgreens' policy to ask all customers for ID and employees who sell alcohol to anyone under the age of 21 are terminated.

To recognize retailers who are in compliance, Drug Free St. Lucie has implemented a retailers recognition program for all those who pass compliance checks. "It is very nice to be appreciated, these things mean a lot," commented Manager Jeff Lipston when his store was presented with a congratulatory certificate for doing their part in preventing underage drinking by checking for ID on alcohol purchases.

Data collected by Drug Free St. Lucie indicates that there were over 125 stores that were a part of this year-long operation, and 106 of those were found to be in compliance.

Drug Free St. Lucie and the St. Lucie County Sherriff Office are committed to continuing to work together to develop and implement a coordinated and proactive approach to reducing and preventing youth substance use and misuse in St. Lucie County.

ness and for exemplifying the words of Albert Camus by making a deposit into the future of our youth in this present moment.








KNOW THE LAW

KNOW THE LAW (A guide for Youth and Parents) – For copies of this booklet email: C. Jovil Wharton, Drug Free St. Lucie Project Coordinator at Jwharton@roundtableslc.org

You must be 21 years of age to purchase, possess, or drink alcohol. If you try to buy an alcoholic beverage in a store or a bar, you will be asked to prove your age. If you cannot prove you are 21 or older, the dealer cannot sell you an alcoholic beverage.

If you are under 21, it is illegal for you to attempt to purchase an alcoholic beverage. If you are 18 years of age or older and this is your first violation, you could be fined up to \$500, confined for up to 60 days, or receive 6 months of probation. If you are under 10 years of age you will face juvenile delinquency sanctions. Anyone who sells or gives alcoholic beverages to a person under 21, or who lets the person drink alcoholic beverages in a bar or store is breaking the law.
