# Remembering Kim

It is very difficult to express the impact of losing Kim Thomas-Pate (1960-2023). Kim's beautiful character speaks to her memory better than any written word ever will. As our longest-serving Roundtable team member of 15 years, Kim was our go-to resource for all things Roundtable, she was our very own "wizard behind the curtain" and the Roundtable historian. There was rarely a question or problem Kim could not answer or solve (unless it was locating a password, she was notorious for losing her passwords). When Kim announced her retirement in 2021, we knew it was going to leave a lasting void here at the Roundtable. Kim Thomas-Pate was not just an Oper-



ations Manager, she was a loving and generous human who made a deep and lasting impression on every person she encountered. Her heart was huge, and she was filled with a true spirit of service to her community. Kim was the type of person who saw the positive in all things and did not sweat the small stuff. She was such a loyal, sincere, and loving woman, coworker, and friend. Knowing her made you want to do and be better.

Kim also had a soft spot for animals and a love of the environment. She often participated in environmental causes and adopted several rescue animals. Kim was so lucky to find her soulmate in Keith, whom she married in May 2016, and enjoyed many years of great fun and adventures together until his passing in 2021. She was a proud mom to Jessie and a proud grandma to her two beautiful grandbabies. Kim is irreplaceable, a one-of-a-kind, and a person who made this world better every day she was in it. Those of us who knew her well and were fortunate enough to work alongside her are better for it.

The poem, "When Great Trees Fall", by Maya Angelou speaks so beautifully to Kim's legacy for all that knew her: You may not think of Kim as a "great tree" in stature or demeanor, because her sincere goodness was understated and without effort; but we are better because she existed. We love you and miss you Kim.

### When Great Trees Fall, by Maya Angelou

When great trees fall, rocks on distant hills shudder, lions hunker down in tall grasses, and even elephants lumber after safety.

When great trees fall in forests, small things recoil into silence, their senses eroded beyond fear.

When great souls die, the air around us becomes light, rare, sterile. We breathe, briefly. Our eyes, briefly, see with a hurtful clarity. Our memory, suddenly sharpened, examines, gnaws on kind words unsaid, promised walks never taken. Great souls die and our reality, bound to them, takes leave of us. Our souls, dependent upon their nurture, now shrink, wizened. Our minds, formed and informed by their radiance, fall away. We are not so much maddened as reduced to the unutterable ignorance of dark, cold caves.

And when great souls die, after a period peace blooms, slowly and always irregularly. Spaces fill with a kind of soothing electric vibration. Our senses, restored, never to be the same, whisper to us. They existed. They existed. We can be. Be and be better. For they existed.

community. **Hidden in Plain Sight Community Partnerships at Work – Local/State Government Sector** Thanks to the generosity of Councilman Bonna, Drug Free St. Lucie hosted a Hidden in Plain Sight event,

at the Port St. Lucie Community Center on February 13th in their TOT room. Thirty (31) participants representing the Boys and Girls Club, Florida Department of Juvenile Justice, RiteLife Services Inc., Center for Disease Control, Florida Department of Health, Department of Children and Families, Career-Source Research Coast, and Palm Beach Behavioral Health Coalition took part in a one (1) hour presentation and tour. Some of the feedback received included: Very enlightening, continue classes like this for awareness; Informative; All parents with children between the ages of 10-24 should be exposed to this presentation; It opened my eyes as to what is out there now; Amazing – even with experience in substance abuse, I learned a lot. Councilman Bonna, who is also a parent, also felt the need to have Hidden in Plain Sight reach more St. Lucie County parents and adults and graciously offered the TOT room for use monthly, pending its availability.

### CADCA's National Leadership Forum 2023

The Roundtable of St. Lucie County's CEO, Teresa Bishop, Drug Free St. Lucie Project Coordinator, Jovil Wharton, and Kids at Hope Project Coordinator, Kevin Singletary, were among some 4,000 attendees at CADCA's 33<sup>rd</sup> Annual National Leadership Forum & SAMHSA 19<sup>th</sup> National Prevention Day, held in National Harbor, Maryland from January 30<sup>th</sup> to February 2<sup>nd</sup>, 2023. With the theme "Together Toward Tomorrow", the organizers created a packed agenda that included: youth exhibits, learning labs, training sessions, state and territory networking meetings, a roundtable discussion with members of Congress on legislative issues, and Capital Hill appointments with State Representatives.

In addition, one of the main highlights of the Forum was the graduation of Coalitions who attended

the National Coalition Academy. Drug Free St. Lucie, was one of the eighty (80) Coalitions that completed either an in-person or virtual 3 weeks of Coalition Training. Congratulations to Drug Free St. Lucie Project Coordinator, Jovil Wharton, and the Operations Manager for the Roundtable, Dana Espinosa, for graduating from the Academy. The next CADA forum will be the Mid-Year Training Institute held July 16-20, 2023, and will offer in-depth, interactive sessions for community coalition leaders and staff on fundamentals such as coalition building, strategic planning, evaluation, and research.

### Prevention, Treatment, Recovery Advocacy Day 2023

If you were in Florida's Capital on February 8<sup>th,</sup> 2023, you would have seen a sea of red wearing prevention coalition members who were there for Prevention, Treatment, Recovery Advocacy Day. This year, the Florida Coalition and Community Alliance, and Drug Free America Foundation partnered with hosting 100 Coalition adults 50 youth from across Florida, who were welcomed to Tallahassee by Doug Simon, Director of the Office of Drug Control, Florida Governor's Office of Drug Control, and Senator Gayle Harrell, Drug Free America Foundation, Moxie Award Recipient.

The focus of this year's visit to Capitol Hill was to raise awareness with Coalition members, legislators and their staffers on three issues, namely; the influx of THC- Delta 8 and similar products being sold over the counter in our neighborhoods; marijuana use during pregnancy and post-partum; and behavioral health equity. Representatives and/or their aides were presented with one-pagers on each of these topics and Coalitions also had the opportunity to speak on issues specific to their

### **Community Partnership at Work – School Sector**

Southern Oaks Middle School reached out to Drug Free St. Lucie once again, this time to partner with them to provide information to parents at their Student Led Conference held on Thursday, February 23rd from 5:15 pm – 7:15 pm. Approximately seventy-five (75) parents and staff toured the *Hidden in Plain Sight* mock teenager's bedroom looking for signs of substance misuse/risky behaviors. Many of the parents and school officials shared that the experience was an eye opener and that they were amazed at what they found. Some parents even commented , "parents need to be more vigilant and aware of what is happening with their children". Drug Free St. Lucie also provided resources/information to parents, such as, Emoji Drug Codes - Decoded, Vaping and Marijuana Concentrates and a variety of fact sheets on illicit drugs.

Markesha was chosen because she continues to be passionate about street outreach and the young females that she inspires.

Markesha returns to Miami often to visit family and friends . Growing up, Markesha and her grandmother were very close, spending most of their time together. From a young age, Markesha saw that her grandmother worked with youth, whether it was at the local Boys and Girls Club, the YMCA, or just the neighborhood kids that were always

around, helping children was always at the forefront of her upbringing. Markesha believes that it is thanks to the beautiful and inspiring role model that her grandmother was in her life, that Markesha now serves youth with that same empathy and unconditional love she witnessed in her grandmother.

Markesha has worked with IGNITE since 2021, and to say that she's an asset to the program is an understatement.
