Message from our CEO

Greetings,

October is National Substance Abuse Awareness Month

Benjamin Franklin wisely said, "An ounce of prevention is worth a pound of cure." When it comes to substance use, this is especially true. Preventing youth substance use—or delaying the "age of onset"—is one of the most effective ways to reduce use later in life.

Substance use is shaped by several risk factors:

- Community: Easy access and visibility of alcohol or drugs can normalize use.
- Families: Lack of communication, supervision, or exposure to use at home increases risk.
- Peers: Friends strongly influence youth choices, and peer pressure encourages experimentation.
- Marketing & Placement: The way alcohol and drug-related items are priced, promoted, or displayed in stores can have an impact. This summer, Drug Free St. Lucie and New Horizons partnered to conduct environmental scans of local stores to study these influences.

There are also **protective factors** that help youth avoid substance use—strong family bonds, supportive schools, positive peers, and clear community standards. That's why Drug Free St. Lucie, the Roundtable's prevention initiative, focuses on awareness and education through campaigns promoted on Drug Free St. Lucie's social media, local radio and television. Join us on our Facebook and Instagram for great messaging, events, tools and other information to prevent substance use by youth in our community.

We promote SAMHSA's "Talk. They Hear You." campaign, reminding parents that youth listen when adults set expectations. We also provide the Hidden in Plain Sight virtual tool to help caregivers recognize warning signs, such as secrecy, declining grades, paraphernalia, or sudden changes in behavior or friends.

Join us the **week of October 27th** for **Red Ribbon Week**, the nation's oldest and largest drug prevention campaign. Started in 1985 to honor DEA Agent Enrique "Kiki" Camarena, it continues today as millions wear red ribbons and participate in activities that promote drug-free living. This is your opportunity to join us in taking a stand—check our calendar of events on page 7.

Together, we can ensure all youth are capable of success—no exceptions.

Continuing Mental Health Advocacy into October

September was a month of powerful conversations and actions around suicide prevention, and we are grateful to everyone who took part in raising awareness and building skills, but our advocacy does not stop there. Mental health is a year-round priority, and October brings new opportunities to learn, connect, and support one another.

Each year, the first full week of October is recognized as Mental Illness Awareness Week, taking place this October 5th through the 11th. This national observance is dedicated to breaking down stigma, raising awareness, and sharing resources to support individuals and families impacted by mental illness. Within that week, on October 10th, communities



across the globe come together for World Mental Health Day, a reminder that mental health is a universal human right and an essential part of overall well-being. Both observances invite us to continue building understanding, compassion, and support for those experiencing mental health challenges.

To carry these messages forward, we encourage the community to explore and share resources such as the Substance Abuse and Mental Health Services Administration (SAMHSA), Mental Health America, and the National Alliance on Mental Illness. These organizations provide educational materials, advocacy opportunities, and direct support that help individuals and communities strengthen their mental health.

In this spirit of raising awareness and connecting people with support, we are especially proud to share that the first volume of the St. Lucie Cares Behavioral Health Resource Guide is officially here! This guide has truly been a labor of love, created to connect our community with the services and resources they need most. Printed copies are now available and ready for distribution, and our online version is under construction so that the guide can continue to grow and stay current as new resources are identified.

St. Lucie Cares is more than just a directory; it's an evolving tool that reflects our community's strengths and commitment to improving access to care. While the first volume marks an exciting milestone, it is only the beginning. We look forward to expanding and refining the guide with even more resources in the months ahead, helping ensure that every member of our community knows where to turn for support.

Boys Council at White City Elementary


Jess Lair once said, "Children are not things to be molded, but are people to be unfolded." This sentiment is at the heart of the Kids at Hope initiative, which encourages children to envision their futures and explore their potential. Every child deserves to have positive experiences and opportunities (ACEs) in their lives. Instead of being confined to a predetermined mold, children should be allowed to explore the world in a nurturing environment where they can fully realize their capabili-



ties. The Kids at Hope Team is collaborating with United Way staff at White City Elementary to bring this vision to life.

On September 16th, the first session of the Boys Council began at White City Elementary. Sessions will be held every other week for a total of ten weeks. Seven boys participated in this program, which is based on an evidence-based curriculum, to

embark on their journey together. These boys shared unique aspects of their personalities, discussed their future dreams, established group expectations, and developed group rituals. Through the Boys Council, they will forge a sense of belonging, build personal assets, and challenge harmful beliefs about masculinity as they navigate their journey to manhood.









October is Substance Use & Misuse Prevention Month. This national campaign is aimed at raising awareness about substance use disorders, promoting prevention strategies, and supporting individuals and families affected by substance use. Substance Use Prevention month coincides with National Red Ribbon week, which is held the week of October 23rd – October 31st. This year's Theme is "Life Is A Puzzle, Solve It Drug Free."

As we celebrate National Red Ribbon Week, we are focused on celebrating and honoring the importance of living a drugfree life. This month our youth and adults pledge to increase their knowledge of learning more about the devastating effects of the misuse of drugs including the misuse of prescription drugs. This pledge renews their commitment to live healthy, productive drug-free lives.




